INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of June 25, 2012 by and among Montage Capital II, L.P., a Delaware limited partnership, for itself and on behalf of GOLD HILL CAPITAL 2008, LP, a Delaware limited partnership (collectively, "Lender") and METRICSTREAM, INC., a Delaware corporation, formerly known as Zaplet, Inc. ("Borrower").

RECITALS

Borrower represents and warrants that Exhibits A, B, and C attached hereto set forth any and all intellectual property rights in connection to which Borrower has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.
