RELEASE OF SECURITY INTEREST
IN TRADEMARKS

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks and the Goodwill, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Released Marks and the Goodwill, and all causes of action for past infringement, if any.
