**ASSIGNMENT AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank of America, N.A., a national banking association, as Administrative Agent for the Lenders ("Agent"), whose address is 901 Main Street, 14<sup>th</sup> Floor, Dallas, Texas 75202, pursuant to that certain Credit Agreement dated as of April 12, 2007, among Agent, Lenders (as defined therein) and Mosaic US Holdings Inc., a Delaware corporation, Mosaic Parent Holdings, Inc., a Delaware corporation, and the Subsidiary Guarantors, as amended by that First Amendment to Credit Agreement dated as of March 23, 2012, (as amended, the "Credit Agreement"), does hereby terminate and forever discharge and release all of its right, title and interest in, to and under that specific Trademark Collateral shown on Exhibit "A" attached hereto, namely, those trademarks listed on Exhibit "A" (the "Released Trademarks"), arising from that certain Trademark Security Agreement dated as of April 12, 2007, between Agent and Mosaic Sales Solutions US Operating Co. LLC, a Delaware corporation (the "Pledgor"), which was recorded in the United States Patent and Trademark Office on or about April 13, 2007, as against the Released Trademarks at Reel/Frame 003522/0435. The Agent hereby retransfers and reassigns to the Pledgor, without representation or warranty, all of the Agent's right, title and interest in, to and under the Trademark Collateral.

The Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
