Release of Security Interest in Trademarks

June 29, 2012

WHEREAS, Sheridan Holdings, Inc., certain of its subsidiaries and Credit Suisse AG, Cayman Islands Branch (“**Credit Suisse**”, as successor to Lehman Commercial Paper, Inc. (“**Lehman**")), in its capacity as Collateral Agent for the Secured Parties (as each term is defined in the Second-Lien Security Agreement (as defined below)), entered into that certain Second-Lien Security Agreement dated as of June 15, 2007 (as amended, supplemented or otherwise modified from time to time, the “**Second-Lien Security Agreement**”);

WHEREAS, pursuant to the Second-Lien Security Agreement, Lehman and Sheridan Healthcare, Inc. (the “**Assignee**”) entered into that certain Second-Lien Intellectual Property Security Agreement dated June 15, 2007 and recorded with the United States Patent and Trademark Office on September 12, 2007 on Reel No. 003619, Frame 0158 (the “**Second-Lien IP Security Agreement**”);

WHEREAS, under the Second-Lien IP Security Agreement, the Assignee granted to Lehman a security interest in certain Collateral (as defined in the Second-Lien IP Security Agreement), including those items set forth on Schedule 1 hereto (the “**Released Collateral**”);

WHEREAS, Lehman and Credit Suisse entered into that certain Second-Lien Intellectual Property Assignment Agreement dated November 2, 2009 and recorded with the United States Patent and Trademark Office on November 5, 2009 on Reel No. 004092, Frame 0050, pursuant to which Lehman assigned its security interest in the Released Collateral to Credit Suisse; and

WHEREAS, Credit Suisse desires to release the security interest granted by the Assignee under the Second-Lien IP Security Agreement in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Credit Suisse, as Collateral Agent for the Secured Parties, does hereby unconditionally, irrevocably and absolutely terminate, release, extinguish and forever discharge the security interest granted under the Second-Lien IP Security Agreement in the Released Collateral, together with all of the goodwill of the business connected with the use of, or symbolized by, such Released Collateral, and hereby unconditionally, irrevocably and absolutely assigns, transfers and conveys to the Assignee all right, title and interest of Credit Suisse in, to and under such Released Collateral and such goodwill granted under the Second-Lien IP Security Agreement. This Release of Security Interest in Trademarks shall be binding upon Credit Suisse’s legal representatives, assigns and successors and upon the Secured Parties. Credit

Suisse also hereby authorizes, and requests, the Director of the United States Patent and Trademark Office or his delegate to record this Release of Security Interest in Trademarks against the Released Collateral.
