Release of Security Interest in Trademarks

WHEREAS, Sheridan Holdings, Inc., certain of its subsidiaries and Credit Suisse AG, Cayman Islands Branch (“**Credit Suisse**”, as successor to Lehman Commercial Paper, Inc.), in its capacity as Collateral Agent for the Secured Parties (as each term is defined in the Second-Lien Security Agreement (as defined below)), entered into that certain Second-Lien Security Agreement dated as of June 15, 2007 (as amended, supplemented or otherwise modified from time to time, the “**Second-Lien Security Agreement**”);

WHEREAS, pursuant to the Second-Lien Security Agreement, Credit Suisse and Sheridan Healthcare, Inc. (the “**Assignee**”) entered into that certain Second-Lien Security Agreement Supplement No. 14-A dated June 30, 2010 and recorded with the United States Patent and Trademark Office on November 22, 2010 on Reel No. 004420, Frame 0001 (the “**Second-Lien Security Agreement Supplement**”);


WHEREAS, under the Second-Lien Security Agreement Supplement, the Assignee granted to Credit Suisse a security interest in certain Additional Collateral (as defined in the Second-Lien Security Agreement Supplement), including those items set forth on Schedule 1 hereto (the “**Released Additional Collateral**”); and


WHEREAS, Credit Suisse desires to release the security interest granted by the Assignee under the Second-Lien Security Agreement Supplement in the Released Additional Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Credit Suisse, as Collateral Agent for the Secured Parties, does hereby unconditionally, irrevocably and absolutely terminate, release, extinguish and forever discharge the security interest granted under the Second-Lien Security Agreement Supplement in the Released Additional Collateral, together with all of the goodwill of the business connected with the use of, or symbolized by, such Released Additional Collateral, and hereby unconditionally, irrevocably and absolutely assigns, transfers and conveys to the Assignee all right, title and interest of Credit Suisse in, to and under such Released Additional Collateral and such goodwill granted under the Second-Lien Security Agreement Supplement. This Release of Security Interest in Trademarks shall be binding upon Credit Suisse’s legal representatives, assigns and successors and upon the Secured Parties. Credit Suisse also hereby authorizes, and requests, the Director of the United States Patent and Trademark Office or his delegate to record this Release of Security Interest in Trademarks against the Released Additional Collateral.

IN WITNESS WHEREOF, Credit Suisse has caused this Release of Security Interest in Trademarks to be duly executed by its officer thereunto duly authorized as of the day and year first above written.
