RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is made as of June 20, 2012, by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., in its capacity as collateral agent (in such capacity, the "Collateral Agent") under the Indenture (defined below).

WHEREAS, Louisiana-Pacific Corporation (the "Company"), Greenstone Industries, Inc., Ketchikan Pulp Company, Louisiana-Pacific International, Inc. and LPS Corporation (collectively, the "Grantors"), are all parties to that certain Indenture, dated as of March 10, 2009, among the Company as issuer, the other Grantors, as guarantors, and The Bank of New York Mellon Trust Company, N.A., as Collateral Agent and as trustee, under which the Company's 13% Senior Secured Notes due 2017 (the "Notes") were issued;

WHEREAS, in connection with the Indenture and pursuant to (a) the Trademark Security Agreement, dated as of March 10, 2009 (the "2009 TSA"), by the Grantors in favor of the Collateral Agent, (b) the Trademark Security Agreement, dated as of February 4, 2010 (the "2010 TSA"), by the Company in favor of the Collateral Agent, and (c) the Trademark Security Agreement, dated as of February 4, 2011 (the "2011 TSA" and collectively with the 2009 TSA and the 2010 TSA, the "TSAs"), by the Company in favor of the Collateral Agent, each Grantor granted a security interest in its trademarks described in each such TSA to the Collateral Agent for the benefit of the holders of the Notes and certain other secured parties;

WHEREAS, the 2009 TSA was recorded on March 11, 2009 in the U.S. Patent and Trademark Office at Reel 3950, Frame 0278, the 2010 TSA was recorded on February 4, 2010 in the U.S. Patent and Trademark Office at Reel 4144, Frame 0345 and the 2011 TSA was recorded on February 7, 2011 in the U.S. Patent and Trademark Office at Reel 4469, Frame 0317;


WHEREAS, the 2009 TSA covered the registered trademarks listed on Schedule A attached hereto (the "2009 Trademarks"), the 2010 TSA covered the registered trademarks listed on Schedule B attached hereto (the "2010 Trademarks") and the 2011 TSA covered the registered trademarks listed on Schedule C attached hereto (the "2011 Trademarks" and collectively with the 2009 Trademarks and the 2010 Trademarks, the "Trademarks"); and

WHEREAS, the Collateral Agent has agreed to release its security interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the Collateral Agent does hereby release and discharge without recourse or warranty the security interest, liens, and all other rights it may have in the Trademarks granted to it by the Grantors pursuant to the TSAs and which were recorded in the United States Patent and Trademark Office.
