RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, Consona Corporation (formerly known as Consona ERP Inc. and Made2Manage Systems, Inc.), an Indiana corporation (“Company”) and **Comerica Bank**, a bank organized under the laws of the State of Michigan (the “Lender”) entered into an Intellectual Property Security Agreement dated as of December 27, 2004 (the “Security Agreement”), pursuant to which the Company pledged to the Lender a security interest in certain intellectual property assets of Company;

WHEREAS, the parties desire to confirm the release of all security interests which had been granted in favor of Lender in the Trademarks, Patents, and Copyrights; and

WHEREAS, the Company has requested and Lender has agreed to provide a document suitable for filing with the USPTO and U.S. Copyright Office for purposes of recording the release of Lender’s security interest in the Trademarks, Patents, and Copyrights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby releases, relinquishes and discharges its security interest and all other rights in the Trademarks, Patents, and Copyrights that Lender has, had, or could have had pursuant to the Security Agreement. Lender hereby further authorizes the Company to take any and all actions, including filing and recording this Release document with the appropriate governmental authorities to effectuate and further document the release made hereby.
