RELEASE OF TRADEMARK SECURITY INTERESTS dated as of May 18, 2012 (this "**Release**"), by Credit Suisse AG, Cayman Islands Branch, as Administrative Agent (as defined below) for the Lenders in favor of each Grantor (as defined below). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Credit Agreement dated as of October 26, 2007 (as amended, restated, supplemented or otherwise modified to the date hereof, the "**Credit Agreement**"), among Bausch & Lomb Incorporated, a New York corporation (the "**Parent Borrower**"), Bausch & Lomb, B.V., a private company with limited liability incorporated under the laws of the Netherlands having its corporate seat in Haarlemmermeer, the Netherlands, number trade register: 34034628 (the "**Dutch Subsidiary Borrower**" and, together with the Parent Borrower, the "**Borrowers**"), WP Prism, Inc., a Delaware corporation ("**Holdings**"), the lenders from time to time party thereto (the "**Lenders**") and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent (in such capacity, the "**Administrative Agent**"). Capitalized terms used in this Release and not defined herein shall have the meanings assigned to such terms in the Credit Agreement.

B. Reference is made to the Pledge and Security Agreement, dated as of October 26, 2007 (as amended, restated, supplemented or otherwise modified to the date hereof, the "**Pledge and Security Agreement**"), among the Parent Borrower, Holdings, certain subsidiaries of the Parent Borrower set forth on Schedule I hereto (collectively, the "**Grantors**") and the Administrative Agent.

C. Reference is made to the Trademark Security Agreement dated as of October 26, 2007, among the Grantors and the Administrative Agent (together with the Pledge and Security Agreement, the "**Security Agreements**").

D. Pursuant to the Security Agreements, the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in, among other things, all right, title and interest of the Grantors in, and under, any Trademarks (as defined in the Security Agreements) owned by the Grantors, including those set forth on Annex I hereto (collectively, the "**Trademark Collateral**"), which security interests were recorded with the United States Patent & Trademark Office on November 14, 2007 at Reel/Frame 003660/490; May 20, 2008 at Reel/Frame 03780/639; August 1, 2008 at Reel/Frame 03827/0672; August 6, 2009 at Reel/Frame 4039/383; November 12, 2009 at Reel/Frame 4095/0490; April 19, 2010 at Reel/Frame 4188/0367; May 19, 2010 at Reel/Frame 4209/0374; August 5, 2010 at Reel/Frame 4255/082; November 1, 2010 at Reel/Frame 4308/0247; March 21, 2011 at Reel/Frame 4502/0078; August 15, 2011 at Reel/Frame 4605/0354; October 28, 2011 at Reel/Frame 4650/0990; and April 23, 2012 at Reel/Frame 4762/0662.

E. Pursuant to the Payoff Letter dated as of May 18, 2012 between, amongst others, the Borrowers, Holdings and the Administrative Agent, the

Administrative Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby absolutely, unconditionally and irrevocably terminate, release, relinquish and forever discharge all right, title and interest (including, without limitation, security interests) of the Administrative Agent in and to the Trademark Collateral. The Administrative Agent hereby assigns, transfers and sets over to the Grantors all right, title and interest that the Administrative Agent, and its predecessors, successors and assigns may have in or to the Trademarks. The Administrative Agent acknowledges and agrees that the Security Agreements have been terminated.

The Parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver all further documents and to do all such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Grantors. The execution and delivery of documents or instruments, including this release, shall be without recourse to, or representation or warranty by, the Administrative Agent.

This Release shall be binding upon the Administrative Agent's successors, assigns and transferees.


