RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is executed and delivered by Wells Fargo Business Credit, Inc. ("Mortgagee").

RECITALS

A. **Campeche Seafood Company, Ltd.** (formerly known as Campeche Seafood Company, Inc., a Texas corporation), a Texas limited liability partnership ("Borrower"), (i) executed that certain Revolving Note (the "Note"), payable to Mortgagee, as payee, dated December 6, 2002, in the original principal amount of TWENTY-TWO MILLION AND NO/100THS DOLLARS (\$22,000,000.00); (ii) entered into that certain Financing Agreement with the Mortgagee, dated December 6, 2002 (as amended, the "Financing Agreement"); and (iii) entered into that certain Term Promissory Note (the "Term Note") payable to Mortgagee, as payee, dated December 6, 2002 in the original principal amount of ONE HUNDRED EIGHTY THOUSAND DOLLARS (\$180,000.00).

B. Payment of the Note and the Term Note and all obligations arising under the Financial Agreement and the outstanding indebtedness evidenced by the Note, the Term Note and the Financing Agreement, are secured by, among other things, the liens, terms and provisions granted by that certain Trademark Security Agreement. (the "Agreement"), made as of December 6, 2002, executed by Borrower, as mortgagor, to and in favor of Mortgagee, as mortgagee, covering, among other things, that certain intellectual personal property

described therein (the "Property") and attached hereto as "Exhibit A" and incorporated herein by reference.

RELEASE

NOW, THEREFORE, FOR VALUE RECEIVED, Mortgagee, the owner and holder in due course of the right to payments and the outstanding indebtedness evidenced by the Note, the Term Note, the Financing Agreement, and the Trademark Security Agreement, and the owner of the liens, terms and provisions contained within the Mortgage, does hereby RELEASE, REMISE and DISCHARGE all right, title and interest in and to the Property which Mortgagee may have or to which Mortgagee may be entitled by virtue of being the owner of the liens created by the Mortgage and does hereby declare the Property fully RELEASED, REMISED and DISCHARGED from the liens created by the Mortgage.

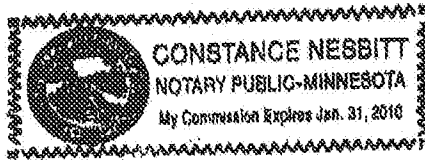
