**RELEASE OF IP
SECURITY AGREEMENT**

WHEREAS, pursuant to that certain IP Security Agreement, dated as of October 23, 2008 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 3875, Frame 0783 and Reel 21731, Frame 0146, SL Industries, Inc., SL Delaware, Inc., SL Delaware Holdings, Inc., MTE Corporation, RFL Electronics Inc., SL Montevideo Technology, Inc., Cedar Corporation, Teal Electronics Corporation, Mex Holdings LLC, SL Power Electronic Corporation, SLGC Holdings, Inc., SLW Holdings, Inc., SL Auburn, Inc., and SL Surface Technologies, Inc. ("Releasees"), granted to Bank of America, N.A. as collateral agent, ("Releasor"), a security interest in and continuing Lien on the Collateral, including the Intellectual Property described on Schedules A and B attached hereto; and

WHEREAS, Releasees have requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of Releasor's security interest in and continuing Lien on the Collateral and the assignment and transfer to Releasees of all of Releasor's rights in and to the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its security interest in and continuing Lien on the Collateral and assigns and transfers to Releasees all of Releasor's rights in and to the Collateral.
