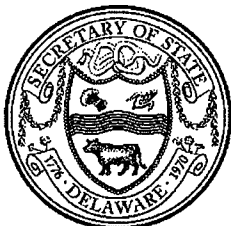



**THIRD:** The name of the surviving limited liability company is Fresh Merge, LLC.


