RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, MSC GROUP, INC., a corporation organized under the laws of the State of Delaware, ZONECARE USA OF DELRAY, LLC, a limited liability company formed under the laws of the State of Florida, OPTIMAL TRANSPORT, LLC, a limited liability company formed under the laws of the State of Florida, O.P.T.I.M.A.L. COMMUNICATORS, LLC, a limited liability company formed under the laws of the State of Florida, and SELECT MRI ACQUISITION, LLC, a limited liability company formed under the laws of the State of Delaware (individually each an "Assignee," and collectively, "Assignees"), and PNC BANK, NATIONAL ASSOCIATION ("Assignor") are party to an Intellectual Property Security Agreement dated July 28, 2009 (the "Security Agreement"); and

WHEREAS, pursuant to such Security Agreement, each Assignee granted to Assignor, for the benefit of the Lenders, a continuing security interest in and Lien upon all of the rights, title and interests of each Assignee to, in and under all of each Assignee's intellectual property, as the term is defined in the Security Agreement (the "Intellectual Property") and such Security Agreement was recorded in the U.S. Patent and Trademark Office ("USPTO") on August 6, 2009, at reel/frame number 004038/0582 against certain trademarks of MSC GROUP, INC. identified in Schedule A annexed hereto and made a part hereof, (the "Trademarks"); and

WHEREAS, Assignor acknowledges full performance of the Obligations, and accordingly desires to execute and deliver to Assignees all deeds, assignments and other instruments as may be reasonably necessary to evidence the release of the security interest in the Trademarks set forth in the Security Agreement.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby relinquishes unto Assignees the continuing security interest in and lien on the Trademarks and otherwise re-assigns, grants and conveys to Assignees any and all rights Assignor may have in or to the Trademarks in order to revest in Assignees full and unencumbered title to said Trademarks.
