This Release shall be binding upon CIT's legal representatives, assigns and successors.

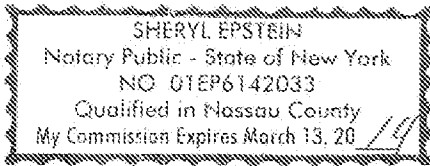
