**RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

WHEREAS, WILMINGTON TRUST, NATIONAL ASSOCIATION (as successor by merger to Wilmington Trust FSB), solely in its capacity as Collateral Agent (the "Agent"), having its corporate trust office at 50 South Sixth Street; Suite 1290; Minneapolis, Minnesota 55402-1544, holds a security interest in certain intellectual property assets of CPM Holdings, Inc., a Delaware corporation, CPM Acquisition Corp., a Delaware corporation, Crown Acquisition Corp., a Delaware corporation, CPM Wolverine Proctor, LLC, a Delaware limited liability company, Crown Iron Works Company, a Delaware corporation, Crown Biofuels, LLC, a Minnesota limited liability company and CPM SA LLC (collectively, the "Grantors"), pursuant to (i) a certain Pledge and Security Agreement, dated as of August 18, 2009 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"; capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement), made by the Grantors in favor of Agent, for the benefit of itself and the other Second Priority Obligees, and (ii) a certain Trademark Security Agreement made by the Grantors in favor of Agent (the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2009 at Reel 4099 / Frame 0284;

NOW, THEREFORE, for value received, the Agent hereby releases and terminates its security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademark and service mark registrations and applications set forth herein on Schedule I. The Agent makes and gives this Release without any recourse, representation, warranty or liability whatsoever.
