**TERMINATION AND RELEASE OF SECURITY INTEREST

This Termination and Release of Security Interest in Patents and Trademarks (this "Termination") is executed by Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent"), in favor of Merchant eSolutions, Inc. a Delaware corporation (the "Grantor").

R E C I T A L S

A. WHEREAS, reference is hereby made to that certain Credit Agreement, dated as of August 28, 2008, as amended and restated on March 31, 2012 (as further amended, modified, renewed or extended from time to time, the "Credit Agreement"), among Grantor, the lenders from time to time party thereto and the Administrative Agent.

B. WHEREAS, reference is hereby made to the Patent and Trademark Security Agreement, dated as of August 28, 2008 (as amended, modified, renewed or extended from time to time, the "Security Agreement"), between Grantor and the Administrative Agent, pursuant to which the Grantor granted to the Administrative Agent a security interest in certain of Grantor's present and future assets, including the patents and trademarks identified on Schedule A attached hereto, to secure the Secured Obligations (as defined in the Credit Agreement);

C. WHEREAS, the Security Agreement was filed with the Trademark Division of the United States Patent and Trademark Office on August 28, 2008, at Reel No. 003844 at Frame No. 0118, to evidence the security interest granted under the Security Agreement; and


D. WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in Grantor's patents and trademarks, including, without limitation, the patents and trademarks identified on Schedule A attached hereto.
