AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Affidavit to Affirm the Release of Security Interest in Trademarks (this "Declaration") is effective as of July 24, 2012. Terms used but not defined herein have the meanings given such terms in the Patent Mortgage Security Agreement (as defined below).

I, Donald J. Dolan, do hereby declare as follows:

1. I am the President, Checks In The Mail, Inc. (formerly iPrint, Inc.), a Delaware Corporation located at 2435 Goodwin Lane, New Braunfels, Texas 78135 (the "Company").
2. In connection with that certain Patent Mortgage and Security Agreement dated as of February 17, 2000 (the "Patent Mortgage and Security Agreement"), iPrint, Inc. granted to Imperial Bank, a California State-Chartered Bank ("Imperial Bank") a security interest and mortgage in and to its entire right, title and interest in, to and under the Intellectual Property Collateral, including the Trademarks listed on Schedule A hereto, as collateral security for the prompt and complete payment and performance of all of its present or future indebtedness, obligations and liabilities including without limitation, such indebtedness, obligations and liabilities under the Loan Agreement and the other documents executed in connection therewith. (the "Security Interest"), which was recorded with the United States Patent and Trademark Office on February 24, 200 at Reel 2027, Frame 0775, and on March 8, 2001 at Reel 2257, Frame 0261.
3. Due to unknown reasons, a termination and release of the Security Interest was not filed with the United State Patent and Trademark Office in connection with the Company's prompt and complete payment and performance of all of its present or future indebtedness, obligations and liabilities with respect to Imperial Bank.
4. The Security Interest has been terminated, released and discharged, and the Security Interest no longer exists in favor of Imperial Bank.

The undersigned, being hereby advised that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this Declaration are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.

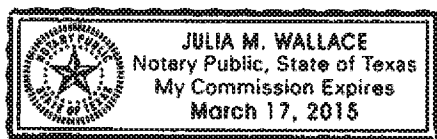
