## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is made as of September 7, 2012, by BANK OF AMERICA, N.A. (as successor to LaSalle Bank National Association), in its capacity as agent (in such capacity, the "Agent") under the Credit Agreement (defined below).

WHEREAS, Advanced Education Systems, LLC, a Maryland limited liability company (the "Grantor") entered into that certain Amended and Restated Credit Agreement, dated March 10, 2008 (the "Credit Agreement"), with various financial institutions and the Agent, pursuant to which such financial institutions (the "Banks") agreed to make loans to, and issue or participate in letters of credit for the account of Grantor, American Home Inspectors Training Institute, Ltd., a Wisconsin corporation, and Keen Skills, Inc., a Florida corporation;

WHEREAS, in connection with the Credit Agreement and pursuant to the Trademark Security Agreement, dated as of March 10, 2008 (the "TSA"), by the Grantor in favor of the Agent, the Grantor granted a security interest in its trademarks described in the TSA to the Agent for the benefit of the Banks;

WHEREAS, the TSA was recorded on March 11, 2008 in the U.S. Patent and Trademark Office at Reel 3737, Frame 0464;


WHEREAS, the TSA covered the registered trademarks listed on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, the Agent has agreed to release its security interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the Agent does hereby release and discharge without recourse or warranty the security interest, liens, and all other rights it may have in the Trademarks granted to it by the Grantor pursuant to the TSA and which were recorded in the United States Patent and Trademark Office.
