**TERMINATION AND FULL RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND FULL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made and entered into as of September 20, 2012 by JPMorgan Chase Bank, N.A. ("JPMorgan"), in favor of Transcat, Inc., an Ohio corporation ("Transcat").

JPMorgan hereby terminates, cancels and releases any and all security interests provided by the Agreement.
