**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARK**

WHEREAS, BANK OF AMERICA, N.A., as Administrative Agent, (the "Administrative Agent"), having its principal place of business at Mail Code TX1-492-14-11, 901 Main Street, 14<sup>th</sup> Floor, Gaming and Leisure Industries Group, Dallas, Texas 75202-3741, holds a security interest in certain intellectual property assets of BOYD GAMING CORPORATION, a Nevada corporation ("Grantor") and certain of Grantor's subsidiaries, pursuant to a certain security agreement among the Administrative Agent, Grantor, and other Grantors (as defined in the Trademark Security Agreement) party thereto, recorded with the United States Patent and Trademark Office on February 4, 2011 at Reel 4468 / Frame 0041 (the "Trademark Security Agreement");

This Release of Security Interest in United States Trademark shall not be construed to be a release of the Administrative Agent's security interest in any trademarks identified in the TRADEMARK SECURITY AGREEMENT other than the Released Trademark. The Administrative Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request in order to perfect, confirm or evidence such release.
