## **Release of Lien on Trademarks**

**This RELEASE OF LIEN ON TRADEMARKS (“Release”)**, dated as of September 14, 2012, is by JPMORGAN CHASE BANK, N.A., Toronto Branch, located at 3 Park Plaza, 9th Floor, Irvine, California, 92614 USA (the **“Collateral Agent”**) as successor in interest to CIT Business Credit Canada Inc. (now named CIBC Asset-Based Lending Inc.) (**“CIT”**), in favor of CATALYST PAPER CORPORATION, a corporation duly organized and existing under the laws of Canada, located at 3600 Lysander Lane 2nd Floor, Richmond, B.C. CANADA V7B 1C3 (the **“Pledgor”**).

**WHEREAS**, pursuant to the terms and conditions of that certain Amended and Restated Security Agreement among the Pledgor, CIT, and certain other parties thereto, dated as of March 10, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the **“Security Agreement”**), the Pledgor granted to CIT, as collateral agent thereunder, a continuing security interest in, among other collateral, all of its right, title and interest in the trademarks set forth on Schedule A hereto;

**WHEREAS**, the Pledgor entered into that certain Grant of Security Interest in United States Trademarks dated as of March 10, 2010 (the **“Agreement”**) in favor of CIT to evidence its grant of a security interest in the trademarks set forth on Schedule A hereto and all products and proceeds thereof;

**WHEREAS**, the Agreement was recorded with the United States Patent and Trademark Office (**“PTO”**) on March 10, 2010 at Reel 004164/Frame 0570, et seq.;

**WHEREAS**, pursuant to the terms and conditions of that certain Agency Resignation and Appointment Agreement dated as of May 31, 2011, CIT transferred its security interest in the Pledged Collateral (as defined below) to the Collateral Agent; and

**WHEREAS**, the secured obligations have been discharged and the security interest in the Pledged Collateral has been released, and the Collateral Agent desires to confirm such release for purposes of recording the release with the PTO.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Release of Lien. The Collateral Agent confirms the release and does hereby release its security interest in (i) each United States trademark registration and trademark application set forth on Schedule A hereto and all of the goodwill of the business connected with the use of, and

symbolized by, each such trademark registration and trademark application (collectively, the “**Trademarks**”) and (ii) all products and proceeds of the foregoing including any claim by the Pledgor against third parties for past, present or future infringement or dilution of any Trademark, or for injury to the goodwill associated with any Trademark (the collateral in (i) and (ii), collectively, the “**Pledged Collateral**”), and hereby reassigns to the Pledgor all right, title and interest of the Collateral Agent in, to and under the Pledged Collateral.

2. Further Assurances. This Release may be recorded by the Pledgor with the PTO. The Collateral Agent also agrees, if reasonably requested by the Pledgor and solely at the Pledgor’s expense, to execute any other documents reasonably necessary to effect the intent and purpose of this Release.
