**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARKS AND PATENTS**

NOW, THEREFORE, intending to be legally bound hereby, the Agent hereby releases and terminates any and all rights, title and interests in and to the Patents and Trademarks, and hereby authorizes each of the Loan Parties or each of Loan Parties' authorized attorneys, representatives, agents or designees to record this Termination and Release of Security Interest in Trademarks and Patents with the U.S. Patent and Trademark Office.
