**TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of October 1, 2012, and made by Goldman Sachs Credit Partners, L.P., having an office at 1 New York Plaza, New York, New York 10004 ("Goldman Sachs") to National Bedding Company L.L.C. ("Grantor").
