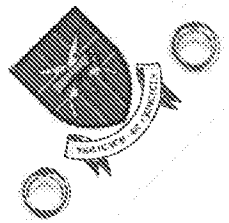

INTELLECTUAL PROPERTY ASSIGNMENT

("PEI"), a Delaware corporation having a place of business at 3000 N.W. 107th Avenue, Miami, Florida 33172 and Perry Ellis International Group Holdings Limited ("PEIGH") an entity duly organized and existing under the laws of the Ireland with a registered office located at Montague Sterling Center, 5th Floor, East Bay Street, Nassau, Bahamas, and Perry Ellis International Europe Limited, an entity duly organized and existing under the laws of Ireland, with an address at Olympic House, Pleasants Street, Dublin 8, Ireland (together, Perry, PEI, PEI Europe and PEIGH, "Assignors"), and Bernette Textile Company LLC, a limited liability company duly organized and existing under the laws of New York having a place of business at 42 West 39th Street, 2nd Floor, New York, New York 10018 ("Assignee") (each a "Party," and collectively, the "Parties"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in that certain Asset Purchase Agreement dated as of September 5, 2012, between Perry, PEI, and PEIGH and Assignee (the "Purchase Agreement").

WHEREAS, Assignors are the owners of the Intellectual Property relating to Assignors business under the Marks and the Domain Names, including, without limitation, the Marks (including those which may be entitled to be registered in additional territories) set forth on Schedule A hereto, and any and all copyright subsisting in all designs of products sold under the Marks;

NOW THEREFORE, for the consideration set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Effective upon Closing, Assignors hereby assign to Assignee:
 - (a) The Intellectual Property, including, without limitation, the Marks and good will associated therewith and the Domain Names, including, without limitation, all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof ("Transferred Rights"); and
 - (b) any and all rights to sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Transferred Rights occurring prior to the Closing, including the right to receive all proceeds and damages therefrom; and
 - (c) any and all rights to obtain renewals, reissues, and extensions of registrations or other legal protections pertaining to the Transferred Rights.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Transferred Rights, and all renewals, reissues and extensions thereof, as fully

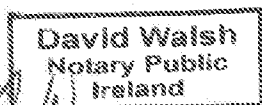
and as entirely as the same would have been held and enjoyed by Assignors had this Assignment not been made.

2. Further Assurances. Assignors shall, at the cost and expense of Assignee, timely execute and deliver any additional documents and perform such additional acts reasonably necessary or desirable to record and perfect the interest of Assignee in and to the Purchased Intellectual Property and the Domain Names, and shall not enter into any agreement in conflict with this Assignment.
