RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of October 10, 2012 (this "**Release**"), by CREDIT SUISSE AG, as Collateral Agent (as defined below). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (a) the Credit Agreement dated as of April 22, 2005, as amended and restated as of August 24, 2009 and November 3, 2010 (as further amended, restated, supplemented or otherwise modified to the date hereof, the "**Credit Agreement**"), among Deltek, Inc., a Delaware corporation (formerly known as Deltek Systems, Inc., the "**Borrower**"), the lenders party thereto (the "**Lenders**") and Credit Suisse AG ("**CS**"), as administrative agent and collateral agent (formerly known as Credit Suisse First Boston, and in such capacity, the "**Collateral Agent**"), (b) the Guarantee and Collateral Agreement dated as of April 22, 2005 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**Guarantee and Collateral Agreement**"), among the Borrower, the Subsidiary Guarantors from time to time party thereto (the "**Subsidiary Guarantors**") and the Collateral Agent, (c) the Trademark Security Agreement dated as of April 22, 2005 (as amended, restated, supplemented or otherwise modified to the date hereof), among the Borrower, Deltek Systems (Philippines), Ltd. and the Collateral Agent, (d) the Subsidiary Trademark Security Agreement dated as of October 14, 2005 (as amended, restated, supplemented or otherwise modified to the date hereof), between Wind2 Software, Inc. and the Collateral Agent; (e) the Subsidiary Trademark Security Agreement dated as of May 1, 2006 (as amended, restated, supplemented or otherwise modified to the date hereof), between WST Corporation and the Collateral Agent; (f) the Subsidiary Trademark Security Agreement dated as of July 24, 2006 (as amended, restated, supplemented or otherwise modified to the date hereof), between C/S Solutions, Inc. and the Collateral Agent; (g) the Trademark Security Agreement dated as of November 3, 2010 (as amended, restated, supplemented or otherwise modified to the date hereof), between the Borrower and the Collateral Agent, and (h) the Subsidiary Trademark Security Agreement dated as of May 11, 2011 among The Washington Management Group, Inc., FSI Holdings, Inc. (collectively the "**Subsidiary Grantors**" and, together with the Subsidiary Guarantors and the Borrower, the "**Grantors**") and the Collateral Agent (the documents set forth in clauses (b) through (h), the "**Collateral Agreements**").

B. Pursuant to the Collateral Agreements, the Grantors granted security interests to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the Trademark Collateral (as defined in each of the Collateral Agreements) and the Trademarks of the Grantors set forth on Schedule I hereto (the "**Trademarks**"), which security interests were recorded with the United States Patent and Trademark Office on (i) May 24, 2005 at Reel/Frame 3090/0403; (ii) May 16, 2006 at Reel/Frame 3309/0218; (iii) May 16, 2006 at Reel/Frame 3309/0260; (iv) August 3, 2006 at Reel/Frame 3361/0591; (v) December 6, 2010 at Reel/Frame 4425/0552 and (vi) July 15, 2011 at Reel/Frame 04584/0280.

C. In connection with the repayment of all Indebtedness under the Credit Agreement, and the release of the security interests under the Loan Documents, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent and the other Secured Parties in and to the Trademarks and the Trademark Collateral granted under the Collateral Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all of the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks and the Trademark Collateral pursuant to the Collateral Agreements shall hereby automatically terminate as provided in the Guarantee and Collateral Agreement. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.


