RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of October 29, 2012, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) in favor of THE HARVARD DRUG GROUP, L.L.C. (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement (as defined below).

WHEREAS, the Grantor executed and delivered to the Collateral Agent a Guarantee and Collateral Agreement dated as of April 8, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”);

WHEREAS, pursuant to the terms and conditions of (i) the Guarantee and Collateral Agreement and (ii) a Trademark Security Agreement executed by the Grantor in favor of the Collateral Agent dated as of April 8, 2010 (as it may be amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), the Grantor pledged, assigned, transferred and granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in the Trademark Collateral, including the trademark registrations and applications listed on Schedule A;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 9, 2010, at Reel 4183, Frame 0001; and


WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent (on behalf of the Secured Parties) hereby terminates, releases and discharges its Security Interest in the Trademark Collateral and retransfers and reassigns to the Grantor all of the Collateral Agent’s right, title and interest in or to the Trademark Collateral, without representation or warranty.
