**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, effective as of November 2, 2012, is made by Bank of America, N.A., as Collateral Agent (as defined below), in favor of Caesars License Company, LLC (the "Company") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to (i) the Trademark Collateral Agreement, dated January 28, 2008 (the "2008 Security Agreement") by Caesars Entertainment Operating Company, Inc. f/k/a Harrah's Operating Company, Inc. (and each Subsidiary Party signatory thereto, including the Company), in favor of Bank of America, N.A., as collateral agent (the "Collateral Agent"), and recorded with The United States Patent and Trademark Office on February 4, 2008 at Reel/Frame No. 3719/0001 and (ii) the Trademark Collateral Agreement, dated June 25, 2009 ("2009 Security Agreement" and together with the 2008 Security Agreement, the "Security Agreements") by the Company and Caesars World, Inc., in favor of the Collateral Agent, and recorded with The United States Patent and Trademark Office on July 2, 2009 at Reel/Frame No. 4015/0198, the Company granted the Collateral Agent a security interest in and to all of its right, title and interest in various trademarks and applications and registrations therefor (the "Trademark Collateral"), including the Trademarks of the Company listed on Schedule I hereto (collectively, the "Assigned Trademarks");

WHEREAS, on November 2, 2012, the Company assigned its rights in the Assigned Trademarks to Harrah's Maryland Heights, LLC, a Delaware limited liability company, having its principal place of business at 777 Casino Center Drive, Maryland Heights, MO 63043;

WHEREAS, the Security Agreements shall continue to remain in full force and effect with respect to the remainder of the Trademark Collateral but excluding the Assigned Trademarks;

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at the Company's sole cost and expense, hereby RELEASES all of its right, title and interest in and to each of the Assigned Trademarks and the goodwill associated with the Assigned Trademarks.
