RELEASE OF SECURITY AGREEMENT

This Release of Security Agreement (this "Release") is given as of October 26, 2012, by DEUTSCHE BANK AG NEW YORK BRANCH, a New York corporation, located at 60 Wall Street, New York, New York 10005 (the "Agent") for the Secured Parties referred to in the Credit Agreement, dated as of June 14, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") to OS Asset, Inc., a Florida corporation (the "Grantor").


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;
