## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Grantors and Agent now wish to record with the United States Patent and Trademark Office the release, relinquishment, termination and discharge of the Agent's security interest in and lien on the Trademark Collateral; and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent, for itself and for the Holders, hereby relinquishes, releases, terminates and discharges its security interest in the Trademark Collateral conveyed to Agent pursuant to the Indenture, Pledge and Security Agreement, and Trademark Security Agreement and/or any other agreement, and Agent hereby reassigns to the applicable Grantor any and all such right, title and interest that Agent may have in the Trademark Collateral, the goodwill associated with the Trademark Collateral, all rights to sue at law or in equity for any infringement or other impairment of the Trademark Collateral including any past infringement or other impairment, including the right to receive all proceeds and damages thereof, and any other right, title and interest Agent may still have in the Trademark Collateral. Agent further agrees to execute and deliver to Grantors any and all further documents or instruments and do any and all further acts which Grantors (or Grantors' agents or designees) reasonably request, at the expense of Grantors, in order to confirm Grantors' right, title and interest in and to the Trademark Collateral, and that Agent makes no further claim to any right, title or interest in or to any of the Trademark Collateral.
