## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This Release of Security Interest ("Release"), is effective of the date set forth below, and is made by JPMORGAN CHASE BANK, N.A., a national banking association with an office located at 270 Park Avenue, 4th Floor, New York, New York 10017 in its capacity and as a successor in interest to Morgan Guaranty Trust Company, (collectively "Grantor"), as agent for the benefit of certain secured parties in favor of the assignors listed in Schedule A ("Grantees").

WHEREAS, the secured obligations have now all been satisfied and Grantees has requested Grantor's release, and Grantor has agreed to release, any and all interest it may have in the Collateral, including as agent for the secured creditors, and assign any and all rights it may have in the Collateral to Grantees.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby release, relinquish and discharge any and all interest it may have in the Collateral and hereby assigns any and all rights it may have in the Collateral to Grantees, in each case, without any representation, warranty, or undertaking by, and without any recourse to, the Grantor.
