RELEASE OF SECURITY AGREEMENT

THIS RELEASE OF SECURITY AGREEMENT, dated December 7, 2012, is made by TD BANK, N.A. (f/k/a TD Banknorth, N.A.), a national banking association (the "Secured Party"). All capitalized terms not defined herein shall have the meanings given to such terms in the Agreement.

WHEREAS, the Secured Party and JSI STORE FIXTURES, INC. (f/k/a JSI STORE FIXTURES ACQUISITIONS CORP.), a Delaware corporation (the "Debtor"), are parties to that certain Security Agreement (Short Form for Patents and Trademarks), dated as of September 22, 2006 (the "Agreement"), recorded with the United States Patent and Trademark Office on September 25, 2006 in its records at Reel: 003396, Frame: 0634 and at Reel: 018296, Frame: 0552;

WHEREAS, to secure the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the TD Loans and all obligations of Debtor under the Loan Agreement, the Debtor granted to the Secured Party a continuing security interest in and to the Patents, Patent Pending and Trademarks set forth in Schedule 1, attached hereto and made a part hereof, together with all registrations of the Patents and Trademarks and the applications therefor, in each case together with the goodwill of the business symbolized by the Trademarks, and all causes of action arising prior to or after the date thereof for infringement of any of the Trademarks and Patents or unfair competition regarding the same (collectively, the "IP Collateral"), all in accordance with the terms and provisions of the Loan Agreement and the Security Agreement; and

WHEREAS, the Secured Party desires to release its rights and security interests in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby fully and finally releases and terminates its security interest in, liens on, and all other rights in, to and under the IP Collateral.

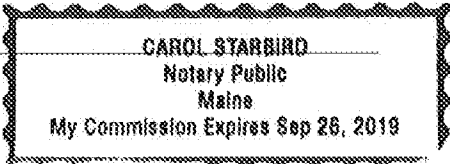
