TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledge, Assignor does hereby sell, assign, transfer and convey to Assignee, its successors and assigns, the entire right, title and interest in the Mark, the common law rights associated therewith, all registrations and applications therefor throughout the world, all of the goodwill of the business associated with the use of and symbolized by the Mark, and that portion of the business to which the Mark pertains, together with all claims for damages by reason of past, present, and future infringement of the rights assigned under this Trademark Assignment, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this transfer to Assignee had not been made.




