

**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of December 11, 2012 by RBS Citizens, N.A., as Administrative Agent (the "Agent"), in favor of Magic Hat IP, LLC, a Vermont limited liability company, Pyramid IP, LLC, a Washington limited liability company, MacTarnahan's IP, LLC, an Oregon limited liability company, Orlio Organic Beer Company, a Vermont corporation, High Falls Licensing Co, LLC, a Delaware limited liability company, Independent Brewers United Corporation (f/k/a Pyramid Breweries, Inc.), a Washington corporation (collectively, the "Grantors").

WHEREAS, the Grantors and the Agent are party to that certain Trademark Security Agreement dated as of November 5, 2010 (as amended and supplemented, the "Security Agreement"), pursuant to which the Grantors granted to the Agent a continuing security interest in and to all of the Grantors' right, title and interest in, to and under all of the trademarks of the Grantors, including, without limitation, the trademarks set forth on Schedule I attached hereto, and all proceeds and products of the foregoing (collectively, the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged;

The Agent hereby releases any and all security interests granted to it, pursuant to the Security Agreement, that it has in the Trademarks (including, but not limited to, the Recordation), and does hereby reassign to the Grantors all interests in such property or rights previously assigned to the Agent under the Security Agreement, without recourse or representation or warranty, express or implied, of any kind.


This Release shall be governed and construed in accordance with the internal laws of the State of New York.

The Agent hereby authorizes and requests that the Commissioner for Trademarks and any other applicable United States government officer record this Release.
