RELEASE OF SECURITY INTEREST

WHEREAS, MAIN STREET CHILDREN'S DENTISTRY AND ORTHODONTICS, LLC, a Florida limited liability company with offices at 13195 SW 134th Street, 2nd Floor, Miami, Florida 33186 ("Grantor"), on November 19, 2010 granted a security interest in the federal trademark registrations shown on the attached Schedule A (collectively the "Marks") to PNC Bank, National Association, which security agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 4486/0946 on February 25, 2011.

3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
