**CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST  
IN UNITED STATES PATENTS, TRADEMARKS, AND COPYRIGHTS**

**THIS CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST IN UNITED STATES PATENTS, TRADEMARKS, AND COPYRIGHTS** (the “**Confirmatory Assignment**”) is made effective as of December 7, 2012, by and from MARLEN INTERNATIONAL, INC. (the “**Assignor**”), a Delaware corporation, whose principal address is c/o Pflingsten Partners L.L.C., 300 North LaSalle Street, Suite 5400, Chicago, Illinois 60654, to and in favor of FIFTH THIRD BANK, an Ohio banking corporation, whose principal address is 222 South Riverside Bank, 30th Floor, Chicago, Illinois 60606, as agent (the “**Assignee**”) for the lenders (the “**Lenders**”) from time to time parties to that certain Loan Agreement dated as of the date hereof by and among Marlen International, Inc., a Delaware corporation (the “**Borrower**”), Assignee and the Lenders, as amended or amended and restated from time to time.

**WHEREAS**, Assignor and Assignee have entered into a Security Agreement of even date herewith (as amended or amended and restated from time to time, the “**Security Agreement**”) pursuant to which Assignor has granted Assignee, for the benefit of the Lenders, a security interest in substantially all of Assignor’s personal property and assets;

**WHEREAS**, Assignor is the owner of the patents (the “**Patents**”), the trademarks and the goodwill of the business in connection therewith (the “**Trademarks**”), and the copyrights (the “**Copyrights**”), all listed on Exhibit A attached hereto, which Patents are issued or pending with the United States Patent and Trademark Office; which Trademarks are registered or pending registration with the United States Patent and Trademark Office; and which Copyrights are registered or pending with the United States Copyright Office.

**WHEREAS**, this Confirmatory Assignment has been granted in conjunction with the security interest granted to Assignee under the Security Agreement;

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Security Agreement.

2. The Security Interest.

(a) This Confirmatory Assignment is made to secure the satisfactory performance and payment of all the Obligations of Assignor, pursuant to the Security Agreement. Upon the payment in full of all Obligations (other than contingent indemnification obligations for which no claim has been made), Assignee shall, upon such satisfaction, execute, acknowledge, and deliver to Assignor an instrument in writing releasing the security interest in the Patents, Trademarks, and Copyrights acquired under this Confirmatory Assignment.

(b) The Assignor hereby collaterally assigns and grants to Assignee, for the benefit of the Lenders, a security interest in (1) all of Assignor’s right, title and interest in and to the Patents, Trademarks, and Copyrights set forth on Exhibit A, now owned or from time to time

after the date hereof owned or acquired by the Assignor, together with (2) all proceeds and products of the Patents, Trademarks, and Copyrights, and (3) all causes of action arising prior to or after the date hereof for infringement of any of the Patents, Trademarks, or Copyrights, or unfair competition regarding the same. Notwithstanding anything to the contrary contained in this clause (b), the security interest created by this Confirmatory Assignment shall not extend to, and the term "Trademark" shall not include any United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law, provided that upon submission and acceptance by the United States Patent and Trademark Office of an amendment to allege use pursuant to 15 U.S.C. Section 1060(a) (or any successor provision), such intent-to-use trademark application shall be considered a Trademark hereunder and the security interest granted hereunder shall extend to such Trademark.

(c) The rights and remedies of Assignee and the Lenders with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Assignment are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

(d) This Confirmatory Assignment shall be governed by the laws of the State of Illinois.
