**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), dated as of October 23, 2012, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, with Credit Suisse AG being a Swiss Bank and joint stock corporation established under Swiss law, with offices located at Eleven Madison Avenue, New York, New York 10010, in its capacity as Collateral Agent (the “**Assignor**”), in favor of SNL FINANCIAL LC, a Virginia limited liability company with offices located at One SNL Plaza, Charlottesville, Virginia 22902 (the “**Assignee**”).

**W I T N E S S E T H:**

**WHEREAS**, the Assignee and the Assignor are parties to (i) that certain Guarantee and Collateral Agreement, dated as of August 17, 2011 (the “**Guarantee and Collateral Agreement**”) and (ii) that certain Trademark Security Agreement, dated as of August 17, 2011 (the “**Initial Trademark Security Agreement**”) and (iii) that certain Trademark Security Agreement, dated as of October 4, 2012 (the “**Additional Trademark Security Agreement**”), and together, the “**Trademark Security Agreements**”);

**WHEREAS**, pursuant to the Trademark Security Agreements, the Assignee pledged and granted to the Assignor, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties now owned or at any time thereafter acquired by Assignee or in which Assignee has or at any time in the future may acquire any right, title or interest: (a) trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, Internet domain names, other source or business identifiers, and designs, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and pending applications filed in connection therewith, including registrations and pending applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I hereto; (b) all goodwill associated therewith or symbolized thereby (together with (a), the “**Trademarks**”); and (c) all Proceeds and products of any and all of the foregoing, all Supporting Obligations and all collateral security and guarantees given by any Person with respect to any of the foregoing (collectively, the “**Trademark Collateral**”);

**WHEREAS**, the Initial Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 22, 2011 at Reel/Frame No. 4609/0717; and

**WHEREAS**, the Assignee desires that the Assignor terminate and release its lien on and security interest in and to all right, title and interest in, to and under all of the Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreements.

**SECTION 2. Termination and Release.** The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and security interest in and to all right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on Schedule I attached hereto, and reassigns and transfers to the Assignee all right, title and interest that the Assignor may have in the Trademark Collateral.

**SECTION 3. Recordation.** The Assignor hereby authorizes the Assignee, or the Assignee's authorized representative, to record this Release with the United States Patent and Trademark Office.


**SECTION 4. Further Assurances.** The Assignor hereby agrees to duly execute and deliver to the Assignee any further documents and to do such other acts that the Assignee (or its agents or designees) reasonably requests, at the Assignee's sole cost and expense, in order to confirm this Release and the Assignee's right, title and interest in the Trademark Collateral.


