Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware (the "DGCL"), the undersigned corporation, Conso International Corporation, a Delaware corporation ("Conso"), hereby certifies the following information relating to the merger (the "Merger") of Wilton Acquisition Sub, Inc., a Delaware corporation (the "Corporation"), with and into Conso:

FIRST: The name and state of incorporation of each of Conso and the Corporation, which are the constituent corporations of the Merger (the "Constituent Corporations"), are as follows:

SECOND: The Agreement and Plan of Merger (the "Merger Agreement"), dated as of December 31, 2012, by and among Wilton Properties, Inc., the Corporation, Conso and, solely for purposes of Article I, Sections 2.10, 2.11, 2.13, 2.15, 2.17, 3.31, 5.2, 5.7, 5.11, 5.13, 6.2, 7.2, Article VIII, Section 9.1 and Article X thereof and solely in its capacity as the Representative (as defined therein), SILLC Holdings, LLC, setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Sections 228 and 251 of the DGCL.

THIRD: The name of the surviving corporation of the Merger shall be Conso International Corporation, a Delaware corporation (the "Surviving Corporation"), and the Corporation will amend Article One of its Certificate of Incorporation, and the new corporation name will be Simplicity Creative Group, Inc., a Delaware corporation.

FOURTH: The certificate of incorporation of the Surviving Corporation shall be Amended and Restated in its entirety at the effective time, and such certificate of incorporation as so amended and restated is attached hereto as Exhibit A.

FIFTH: The merger is to become effective at the time and on the date of the filing of this Certificate of Merger with the Secretary of State of the State of Delaware in accordance with the DGCL.

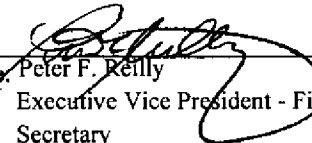
SIXTH: The executed Merger Agreement is on file at 261 Madison Avenue, New York, NY 10016, the place of business of the Surviving Corporation.
