This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of December 28, 2012 ("Effective Date") by Wells Fargo Capital Finance, Inc. (formerly known as Wells Fargo Foothill, Inc.), a California corporation ("WFCF"), in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, "Grantee"), in favor of Embarcadero Technologies, Inc., a Delaware corporation ("Borrower"), EMB Holding Corp., a Delaware corporation ("Parent"), and SHC Ambeo Acquisition Corp., a Delaware corporation (collectively, the "Grantors").

WHEREAS, reference is made to that certain Second Lien Credit Agreement dated as of June 25, 2007 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among the lenders identified on the signature pages thereof, Grantee, Parent and Borrower;

WHEREAS, pursuant to the terms and conditions of that certain Second Lien Trademark Security Agreement dated as of June 25, 2007 (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement"), by and among the Grantors and Grantee, the Grantors granted to Grantee a security interest in all of the Grantors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 27, 2007 at Reel 3568, Frame 0984; and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to the Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.


