**RELEASE OF SECURITY INTEREST IN

This RELEASE, dated as of January 30, 2013, is made by JPMORGAN CHASE BANK, N.A., as successor in interest to Bear Stearns Corporate Lending Inc., a New York banking corporation, as administrative agent (the "Administrative Agent") pursuant to the Guarantee and Collateral Agreement dated as of October 5, 2006 (as amended, supplemented or otherwise modified from time to time, (the "Agreement"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Agreement.

WHEREAS, Renfro Acquisition Inc., a Delaware corporation, Renfro Corporation, a North Carolina corporation and successor to RC Merger Corp., and Renfro Services Co., Inc., a North Carolina corporation (the "Grantors") and the Administrative Agent are parties to the Agreement;

WHEREAS, pursuant to the Agreement, recorded with the United States Patent and Trademark Office on October 9, 2006 at Reel/Frame Nos. 3404/0693 and 18362/0893 and with the United States Copyright Office on October 10, 2006 at V3543 D602, the Grantors granted the Administrative Agent a security interest in its Collateral including all Intellectual Property;

WHEREAS, pursuant to the Intellectual Property Security Amendment dated December 17, 2010 ("Security Amendment") and recorded with the United States Patent and Trademark Office on December 17, 2010 at Reel/Frame No. 4435/0990, the Grantors supplemented the Agreement with newly acquired Intellectual Property;

WHEREAS, pursuant to Section 8.15(a) of the Agreement and Section 10.14(b) of the Credit Agreement (as defined in the Agreement), the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in and to the Intellectual Property and associated goodwill, including those Patents, Trademarks, and Copyrights, set forth in Schedule 1.

NOW, THEREFORE, the Administrative Agent hereby RELEASES, without recourse its security interest in all right, title and interest in and to the Intellectual Property and associated goodwill, including those Patents, Trademarks, and Copyrights, set forth in Schedule 1.






