RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of February 22, 2013 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Agent") for the Lenders (as defined in the Credit Agreement referred to in the Security Agreement (as defined below)).

W I T N E S S E T H:

WHEREAS, RSI HOME PRODUCTS MANAGEMENT, INC., a Delaware corporation (the "Grantor"), and certain other entities executed that certain Security Agreement, dated as of December 8, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Agent, pursuant to which the Grantor granted a security interest to the Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 004435, Frame 0325 on December 16, 2010; and

WHEREAS, the Agent has agreed to release all its liens on the trademarks and trademark applications of the Grantor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.








