- 2. Release of Security Interest. The Agent hereby terminates, releases, and discharges its Security Interest in the Trademark Collateral, and any right title and interest of the Agent in such Trademark Collateral shall hereby cease and become void.
- 3. Filing of the Release; Further Assurances. The Agent hereby authorizes the filing of this Release in the United States Patent & Trademark Office by the Grantors (or the Grantors' designee) at the request and sole expense of the Grantors, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
