RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST having an effective date of March 13, 2013 by PNC Bank, National Association ("Assignee"), in favor of Spartech Corporation, a Delaware corporation, and certain of its subsidiaries (collectively, "Borrower").

WHEREAS, Borrower and Bank of America, N.A. ("B of A") are parties to a certain Security Agreement dated as of September 10, 2008 (the "Security Agreement"), and recorded in the United States Patent and Trademark Office on September 12, 2008 at Reel 021523, Frame 0412 (Patents) and on September 12, 2008 at Reel 3852, Frame 0753 (Trademarks) under which Borrower granted B of A a security interest in certain patent and trademark collateral including but not limited to certain of the patents and trademarks listed on Schedule A attached hereto (collectively, the "IP Collateral"); and

WHEREAS, B of A and Assignee are parties to a certain Assignment Agreement dated as of June 9, 2010, and recorded in the United States Patent and Trademark Office on June 16, 2010 at Reel 024539, Frame 0869 (Patents) and on June 16, 2010 at Reel 4226, Frame 0001 (Trademarks) under which B of A transferred all of its right, title and interest under the Security Agreement to Assignee; and

WHEREAS, Borrower and Assignee are parties to a certain Amended and Restated Security Agreement dated as of June 9, 2010, and recorded in the United States Patent and Trademark Office on June 16, 2010 at Reel 024539, Frame 0879 (Patents) and on June 16, 2010 at Reel 4226, Frame 0278 (Trademarks) under which Borrower granted Assignee a security interest in certain patent and trademark collateral including but not limited to the IP Collateral; and


WHEREAS, Borrower has requested that Assignee release the security interest in the IP Collateral; and

WHEREAS, Assignee desires to assign, release, terminate, discharge, grant, convey, deliver and transfer its continuing security interest in all of the IP Collateral to Borrower.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of Borrower in, to and under the IP Collateral and reassigns and transfers any and all interest that Assignee may have in the IP Collateral to Borrower.
