

#### RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of February 14, 2013 (this "*Release*") is made by Credit Suisse AG, as collateral agent (the "*Collateral Agent*") acting for the benefit of the Secured Parties. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

- A. Reference is made to the Credit Agreement dated as of August 17, 2012 (as amended, supplemented or otherwise modified through the date hereof, the "Credit Agreement"), among Fairway Group Acquisition Company, a Delaware corporation (the "Borrower"), Fairway Group Holdings Corp., a Delaware corporation ("Holdings"), the Lenders from time to time party thereto, and Credit Suisse AG, as administrative agent and Collateral Agent.

The Collateral Agent hereby assigns, transfers and sets over to the Trademark Grantor all right, title and interest that the Collateral Agent has in or to the Released Trademarks under the Security Agreement and the Trademark Security Agreement.
