## RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This Release of Security Interest in Trademarks (this “Release”) is made as of March 21, 2013 (“Effective Date”) by CREDIT SUISSE AG, in its capacity as administrative and collateral agent (the “Collateral Agent”) for the benefit of SUPERVALU INC., SUPERVALU HOLDINGS, INC., SUPERVALU PHARMACIES, INC., W. NEWELL & CO., LLC, FF ACQUISITION, L.L.C., MORAN FOODS, LLC, RICHFOOD, INC., SFW LICENSING CORP., ACME MARKETS, INC., AMERICAN STORES COMPANY, LLC, NEW ALBERTSON’S, INC., SHAW’S SUPERMARKETS, INC., and STAR MARKETS COMPANY, INC. (the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Grant of Security Interest in United States Trademarks dated as of August 30, 2012 by and between the Grantors and the Collateral Agent (the “Trademark Security Agreement”), the Grantors have granted to the Collateral Agent a continuing security interest in (a) all of each Grantor’s right, title and interest in, to and under to the United States trademarks, tradenames, trade styles and service marks and all trademark registrations and trademark applications and recordings (the “Marks”) set forth on Schedule A attached hereto, (b) all rights and privileges arising under applicable law with respect to each Grantor’s use of any Marks, and all reissues, extensions, continuation and renewals thereof, (c) all prints and labels on which such Marks appear, (d) the goodwill of the business symbolized by each of the Marks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Marks and (e) all rights corresponding thereto (the “Trademark Collateral”); and

WHEREAS, the Trademark Security Agreement was executed by the Grantors and was previously recorded in the United States Patent and Trademark Office (“USPTO”) on October 18, 2012 at Trademark Reel No. 4883, Frame No. 0696, Reel No. 4884, Frame No. 0152, Reel No. 4884, Frame No. 0525, Reel No. 4884, Frame No. 0561, Reel No. 4884, Frame No. 0414, Reel No. 4884, Frame No. 0488, Reel No. 4884, Frame No. 0299, Reel No. 4884, Frame No. 0342, Reel No. 4884, Frame No. 0226; Reel No. 4884, Frame No. 0189; Reel No. 4884, Frame No. 0262, Reel No. 4884, Frame No. 0378, and Reel No. 4884, Frame No. 0450, and

WHEREAS, the Collateral Agent acknowledged full performance of the Secured Obligations (as defined in the Trademark Security Agreement), and accordingly the Collateral Agent has agreed to release its continuing security interest in all of the right, title, and interest of the Grantors in the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to the Grantors;

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, relinquishes and discharges, all of its continuing security interest in all of the Grantors’ right, title and interest in, to and under the Trademark Collateral, and re-assigns to the Grantors any and all right, title or interest it may have in such Trademark Collateral, all without warranty and representation of any kind.


The Collateral Agent hereby authorizes the Grantors, or the Grantors’ authorized representatives to: (a) record this Release with the USPTO and/or any other applicable governmental office or Agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral. The Collateral Agent agrees to execute and deliver to the Grantors all other instruments and other documents as may be necessary or proper to effectuate and evidence the release of the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.
