**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of April 1, 2013 (this "Release"), is made by Wells Fargo Bank, National Association, as administrative agent (in such capacity, "Agent") under the Credit Agreement referenced in the Grant of Trademark Security Interest described below, in favor of Del Taco LLC (the "Grantor") as follows:
