**TERMINATION AND RELEASE OF  
SECURITY INTEREST  
IN TRADEMARK RIGHTS**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this “Release”) is made as of April 1, 2013 (the “Effective Date”) by Bank of America, N.A., as collateral agent (in such capacity, the “Agent”), in favor of 2GIG Technologies, Inc. (the “Grantor”).

**WHEREAS**, pursuant to the terms and conditions of that certain Security Agreement, dated as of November 16, 2012, between the grantor parties thereto and the Agent (the “Security Agreement”) and the 2GIG Trademark Security Agreement (defined below), a security interest was granted by the grantor parties (including the Grantor) to the Agent in certain collateral, including the Trademark Collateral (as defined below) (the “Security Interest”);

**WHEREAS**, pursuant to the Security Agreement, the Agent and the Grantor entered into that certain Trademark Security Agreement with respect to the Trademark Collateral (the “2GIG Trademark Security Agreement”) and recorded the 2GIG Trademark Security Agreement with the Trademark Division of the U.S. Patent & Trademark Office on November 20, 2012, at Reel 4904 and Frame 0096;

**WHEREAS**, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:


1. **Definitions.** The term “Trademark Collateral,” as used herein, shall mean all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term “Trademarks” shall have the meaning provided by reference in the 2GIG Trademark Security Agreement.

2. **Release of Security Interest.** The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. **Further Assurances.** The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
