## RELEASE OF TRADEMARK SECURITY INTEREST

RELEASE OF TRADEMARK SECURITY INTEREST ("*Release*"), dated as of April 1, 2013, by Brookside Mezzanine Fund II, L.P., a Delaware limited partnership (the "*Lender*") in favor of Utrecht Manufacturing Corporation, a Delaware corporation ("*Debtor*"). Capitalized terms used but not defined herein shall have the meanings set forth in the Note Purchase Agreement (defined below).

### WITNESSETH:

WHEREAS, Debtor, certain of its Affiliates and the Lender entered into a Note Purchase Agreement dated as of the October 31, 2011 (as amended or modified from time to time, the "*Note Purchase Agreement*");

WHEREAS, in connection with the Note Purchase Agreement, Debtor executed and delivered to the Lender a Grant of Trademark Security Interest dated as of October 31, 2011, for filing with the United States Patent and Trademark Office (as amended or modified from time to time, the "*Grant*");

WHEREAS, pursuant to the Grant, Debtor granted to and created in favor of the Lender a continuing security interest in, and lien on, all of Debtor's presently existing or thereafter acquired Trademarks including, without limitation, the Trademarks set forth on **Schedule A** hereto, and all proceeds and products thereof; and

WHEREAS, the Lender desires to release its rights and security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademarks, and (ii) any and all other rights it may have under the Grant.
