TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of April 2, 2013, and made by COMERICA BANK, a Texas banking association ("Grantee") to NCIRCLE NETWORK SECURITY, INC. ("Grantor").

- 2. <u>Release of Security Interest</u>. Grantee hereby terminates the Security Agreement and terminates, releases, and discharges its security interest in the Trademarks and reassigns to the Grantor all right, title and interest of Grantee in the Trademarks.
