### Release of Grant of Security Interest in Trademark Rights

This Release is executed as of this 10<sup>th</sup> day of April, 2013, by The Royal Bank of Scotland PLC, as security agent (in such capacity, the “**Security Agent**”) for the Lenders (as hereinafter defined), for the benefit of the Grantors (as hereinafter defined).

WITNESSETH:

WHEREAS, the Security Agent acts as security agent for the banks and other financial institutions or entities (the “**Lenders**”) from time to time party to (i) the Senior Facilities Agreement, dated April 3, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**SFA**”) among, *inter alia*, Doncasters Group Limited (the “**Parent**”), certain of the Lenders, the Security Agent and The Royal bank of Scotland PLC, as facility agent, (ii) the Mezzanine Facility Agreement, dated April 3, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**MFA**”) among, *inter alia*, the Parent, certain of the Lenders, the Security Agent and Credit Suisse AG, London Branch, as facility agent, and (iii) the PIK Facility Agreement, dated April 3, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**PIKFA**”, and together with the SFA and the MFA, the “**Facilities Agreements**”) among, *inter alia*, the Parent, certain of the Lenders, the Security Agent and Credit Suisse AG, London Branch, as facility agent.

WHEREAS, pursuant to the Facilities Agreements, the Grantors, the Security Agent, and the other parties thereto, entered into that certain Security Agreement, dated as of May 15, 2007 (as amended on September 20, 2010 and as may be further amended, amended and restated, supplemented or otherwise modified, the “**Security Agreement**”).

WHEREAS, pursuant to the Security Agreement, Doncasters Limited, Nelson Stud Welding, Inc., FastenTech, Inc., The Ferry Cap & Set Screw Company, and Spiegelberg Manufacturing, Inc., (the “**Grantors**”) and the Security Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of May 15, 2007 (the “**Trademark Security Agreement**”) which Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on May 30, 2007, at Reel 3551, Frame 0345, and under which the Grantors have granted a continuing security interest in, and lien on, all of its right, title and interest in and to certain Collateral (as defined in the Trademark Security Agreement)(the “**Intellectual Property Collateral**”) of the Grantors, including the trademarks listed on Schedule 1 hereto, to the Security Agent, for the benefit of itself and the Lenders.

WHEREAS, in connection with the full satisfaction and discharge of all Obligations (as defined in the Security Agreement), the Lenders have agreed to release the security interests created under the Trademark Security Agreement on the terms and conditions set forth in that certain Global Deed of Release dated April 9, 2013 by the Security Agent, Credit Suisse AG, London Branch and National Westminster Bank PLC in favor of each of the companies listed in Schedule 1 thereto.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent, acting on behalf of the Lenders, hereby (i) terminates the Trademark Security Agreement, (ii) terminates and releases the security interests over, and lien upon, the Intellectual Property Collateral created by the Trademark Security Agreement, and (iii) re-assigns to the Grantors any right, title and interest it may have in, to and under the Intellectual Property Collateral.

For the avoidance of doubt, Intellectual Property Collateral shall include all trademarks and trademark applications as to which any Grantor has granted a security interest to the Security Agent, regardless of whether listed on Schedule 1.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
