**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (this "Release"), effective as of April 11, 2013, is granted by Bank of America, N.A., in its capacity as Agent for and on behalf of the Secured Parties (the "Agent"), in favor of Tekni-Plex, Inc., a Delaware corporation, Plastic Specialties and Technologies, Inc., a Delaware corporation, Plastic Specialties and Technologies Investments, Inc., a Delaware corporation and TPI Acquisition Subsidiary, Inc., a Delaware corporation (the "Grantees"), as follows:

**WITNESSETH:**

WHEREAS, pursuant to the terms of that certain First-Lien Loan and Security Agreement, as amended, modified, restated and/or supplemented from time to time ("Loan and Security Agreement") and the Form of Grant of Security Interest in Trademarks ("Trademark Security Agreement"), both dated as of November 19, 2010 by and among the Agent and the other parties thereto, the Grantees have granted to the Agent a security interest in (i) all of the Grantees' rights, titles and interests in, to and under the trademark, trademark registrations, trademark applications and domain names set forth in the schedule attached to the Trademark Security Agreement (the "Secured Marks"), (ii) all proceeds and products of the Secured Marks ("Trademark Proceeds"), (iii) the goodwill of the businesses with which the Secured Marks are associated ("Goodwill"); and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Secured Marks or unfair competition regarding the same ("Causes of Action");

WHEREAS, the United States Patent and Trademark Office recorded the Trademark Security Agreement against the Secured Marks at Trademark Reel 004518, Frame 0662 on March 30, 2011; and

WHEREAS, the Agent wishes to release and restore all right, titles and interest in and to (i) the Secured Marks that are set forth in Schedule A attached hereto ("Released Marks"), (ii) the Trademark Proceeds related to the Released Marks, (iii) the Goodwill related to the Released Marks, and (iv) the Causes of Action related to the Released Marks (collectively, the "Released Trademark Collateral") to the Grantees and to dissolve any and all liens and encumbrances respecting the Released Trademark Collateral under the Loan and Security Agreement and the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the Agent, pursuant to Section 13.2.1 of the Loan and Security Agreement, hereby releases, discharges, quit claims and relinquishes unto the Grantees its security interest in and lien on any and all right, titles and interest in the Released Trademark Collateral. All capitalized terms used but not defined in this Release shall have the meanings ascribed to them in the Loan and Security Agreement.
