RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is executed as of April 23, 2013 by Bank of America, N.A., as Lender (the "Secured Party") under that certain Credit Agreement described below. Any capitalized term not otherwise defined herein shall have the meaning ascribed to it in the Trademark Assignment (as defined below).

WHEREAS, Atlas Paper Mills, LLC (the "Assignor") and the Lender have previously entered into that certain Amended and Restated Credit Agreement dated as of May 11, 2009 (as amended and in effect from time to time, the "Credit Agreement");

WHEREAS, contemporaneously with the Assignor entering into the Credit Agreement, the Assignor entered into that certain Trademark Collateral Security and Pledge Agreement, dated as of May 11, 2009 (as amended, the "Trademark Assignment") in favor of the Lender;

WHEREAS, pursuant to the Trademark Assignment, the Assignor granted to the Lender, as security for the Obligations (as defined in the Credit Agreement), a continuing security interest in all of the Assignor's right, title and interest in and to those certain trademarks listed on Schedule A to the Trademark Assignment, including but not limited to the Trademark listed on Exhibit A hereto (the "Subject Trademark"); and

WHEREAS, the Assignor has requested that the Lender release the liens and security interests granted to the Lender by the Assignor with respect to the right, title and interest in and to the Subject Trademark pursuant to the Trademark Assignment or otherwise.

For good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby:

(a) releases the liens and security interests granted by the Assignor to the Lender pursuant to any security agreement (including but not limited to the Trademark Assignment) in the right, title and interest of the Assignor in and to the Subject Trademark solely to the extent of the Assignor's interest therein; and

(b) to the extent the Lender shall be deemed to have any right, title or interest in the Subject Trademark, retransfers and reassigns to the Assignor all of such right, title and interest solely with respect to the Subject Trademark.

This Release of Security Interest in Trademarks shall be governed by the laws of the State of New York.
